IV. EDUCATIONAL ISSUES FOR DISCUSSION AND POSSIBLE ACTION

<u>Field Trip Request – International Submarine Race</u>

The Old Saybrook High School Submarine Team is requesting permission to attend the International Submarine Races at the Naval Services Warfare Center in Caderock, Maryland. The submarine team is comprised of students between 10th and 12th grade. Students learn how to design, construct, test, and race a wet one-man submarine. Each student will have the opportunity to pilot the submarine and will earn SCUBA certification. The team will leave Old Saybrook High School on the morning of June 25, for Rockville, Maryland. Submarine races will take place between June 26-June 30. Students will return to Old Saybrook on June 30.

Student Assessment Update

Amity Goss, Director of Curriculum, Instruction, and Assessment, presented the recently released state standardized test scores from last spring's administration.

For the first time, all eleventh graders participated in the School day SAT, which was the first administration of the new SAT. Because this is a new test and because all students took this test, regardless of college and career plans, the data is not comparable to previous years' SATs. On the whole, Old Saybrook students scored better than their peers statewide. There was an 11-point gap in math and a 15-point gap in English language arts between Old Saybrook students and their grade level peers across the state.

Smarter Balanced scores in grades 3-8 were up across the state, but down in Old Saybrook, on the whole. In nine of 12 subcategories, Old Saybrook students performed better in 14-15 than they did in 15-16, while the state averages showed gains in all 12 areas. Mathematics continues to be a weakness both in the state and in Old Saybrook, though students across the state outscored Old Saybrook peers at one grade level and scored similarly in a second in the area of mathematics. Old Saybrook showed particularly strong scores in fourth and fifth grade mathematics and in seventh and eighth grade English language arts.

CMT/CAPT Science scores were largely unchanged, though the 15-16 scores were higher at all grades (5,8,and 10) than the five year averages for the same test. Because this test remains focused on the former Connecticut science standards, rather than the current Next Generation Science Standards (NGSS), the data bears further investigation.

Director Goss reviewed the following next steps for continued assessment monitoring and improvement:

- continue the math pilots, K-8
- continue math coaching
- monitor adoption of Next Generation Science Standards (NGSS)
- monitor ELA integration models and impact on student learning
- cross-reference data from these assessments with local assessments and universal screenings
